The Sangamon County Citizen Survey is a collaborative effort between the UIS Center for State Policy \& Leadership, the Community Foundation for the Land of Lincoln, and the United Way of Central Illinois. The project's purpose is to establish benchmarks and assess changes in residents' assessments of the quality of life in Sangamon County. The periodic survey provides local leaders, community organizations, and citizens with longitudinal insight into issues facing local residents. Each survey includes core items that serve as barometers of public opinion as well as topic-specific items that will provide timely data for local leaders. The following areas are covered in the 2019 survey: social well-being, day to day life, population, legal changes, equality, success, the economy, civic engagement, leadership, personal health, social health, the environment, and culture/recreation.

Since its outset, the survey has been guided by a steering committee of representatives from the community. The committee provides input into the questionnaire by including topics of interest to leaders in the county. The inaugural survey was conducted in 2013 while a second survey was completed in 2015 . The 2017 study expanded sections on infrastructure and the economy. Many questions in the current poll remain the same as in the previous versions- this is necessary to make comparisons over time. The current survey also contains new questions on topics which have recently received attention in the community. These topics include economic development, downtown Springfield, gambling, and recreational marijuana.

## Methodology

The University of Illinois Springfield Survey Research Office (SRO) is dedicated to the principles of transparency in research and is a charter member of the American Association for Public Opinion Research (AAPOR) Transparency Initiative. Membership entails adherence to AAPOR's code of ethics as well as a commitment to promoting understanding of survey methodology and how it relates to survey quality. ## Funding

The Community Foundation for the Land of Lincoln, the United Way of Central Illinois and, the Center for State Policy and Leadership at the University of Illinois Springfield commissioned the UIS Survey Research Office and the Institute for Legal, Legislative, and Policy Studies to conduct a mixed-mode survey (mail and web) of adults living in Sangamon County. The survey was conducted from June 1, 2019 to July 3rd, 2019 via mail questionnaire with the option to take the survey via the Qualtrics Research Suite.

## Sampling Frame

The sample is an address based sample (ABS) of 8,000 households in Sangamon County, Illinois. Those in zip codes 62702 and 62703 were oversampled to better obtain representativeness with regards to income and minority status. We do this to compensate for low response rates for areas of lower income and higher minority populations. To calculate the percentage for the oversampled zip codes, we took the percentage of individuals living in zip codes 62702 and 62703 and divided it by the unweighted percentage of responses for these zip codes in a previous survey conducted by SRO. In the sample, 7,324 households ( $92 \%$ ) had a name appended to the address. The sampling frame excludes those who do not have an address (such as the homeless) as well as those living in group quarters (such as a boarding house or a fraternity/sorority), and those who may have moved into a formerly vacant address (a delivery point that has been unoccupied for 90 days or more). The survey also excludes those who are unable to take the survey in English. The sample was developed by personnel at Marketing Systems Group for the Survey Research Office.

## Recruitment

The Survey Research Office sent an envelope to addresses containing an introductory letter, the mail questionnaire, and a postage paid business reply envelope. Households with a matching name were addressed to the name of the individual. Individuals without a matching name were addressed simply to "resident." The introductory letter tells respondents that the survey is sent to the household rather than the individual listed on the envelop. Because all individuals over the age of 18 residing in Sangamon County were considered eligible to participate there is no purposive withinhousehold selection.

A total of 652 interviews were completed ( 612 via mail; 40 via the web using Qualtrics Research Suite). Additionally, zero individuals completed some questions in the survey but not enough to be considered completes and four individuals sent back blank questionnaires. These were coded as implicit refusals. 19 persons sent back the questionnaire but after the field period. 28 questionnaires came back as undeliverable. Finally, two questionnaires were returned with responses indicating no one at the household was able to take the survey. The majority of questionnaires were never returned $(7,294)$.

The Response Rate for the survey (AAPOR Response Rate 3) is $8 \%$, the Cooperation Rate is $99 \%$ (AAPOR Cooperation Rate 3), and the refusal rate is $.006 \%$ (AAPOR Refusal Rate 3). The table below shows the final disposition of cases which were coded in accordance with guidelines set forth by AAPOR as well as outcome rates calculated using AAPOR's response rate calculator.

## Precision of Findings

The margin of sampling error for the survey is $3.8 \%$ at the $95 \%$ confidence level, consistent with the 2017 survey. When examining subgroups, the margin of error will increase. The margin of sampling error has not been adjusted for design effect.

## Direction of Sangamon County

- $52 \%$ of respondents report that things are generally heading in the right direction. $48 \%$ of respondents report that things are on the wrong track.
- $57 \%$ of residents born outside Sangamon County think things are heading in the right direction compared to $47 \%$ of residents born in Sangamon County.
- Female respondents ( $54 \%$ ) and male respondents $(52 \%)$ report things are generally heading in the right direction at similar rates.
- White respondents $(52 \%)$ report things are generally heading in the right direction compared to non-white respondents ( $51 \%$ ) at similar rates.
- Education has a notable impact on outlook, with those that have less than a high school education $(77 \%)$ and those that have a graduate degree ( $66 \%$ ) were more likely than other educational groups that Sangamon County is heading in the right direction.
- Those reporting an annual household income of greater than $\$ 100,000$ report things are heading in the right direction at a higher rate ( $63 \%$ ) than those reporting under $\$ 30,000(50 \%)$, between $\$ 30,001$ and $\$ 60,000(50 \%)$, and $\$ 60,001$ to $\$ 100,000(48 \%)$.

## Quality of Life

- Men ( $41 \%$ ) are slightly more likely than women $(39 \%)$ to rate their life in the 8 to 10 range.
- $42 \%$ of white respondents rate their life in the 8 to 10 range compared to $28 \%$ of non-white respondents.
- Slightly over half ( $52 \%$ ) of respondents with graduate degrees rate their quality of life between an 8 and a 10 compared to $10 \%$ of those with less than a high school degree.
- Those reporting an annual household income greater than $\$ 100,000$ are more likely $(40 \%)$ to rate their life between 8 and 10 compared to those reporting under $\$ 30,000(18 \%)$, between $\$ 30,001$ and $\$ 60,000(31 \%)$, and $\$ 60,001$ to $\$ 100,000(39 \%)$.

## Recommending the Area

- $50 \%$ were likely ( 6 through 10 ) to recommend the area, $15 \%$ were neither likely or unlikely (5), and $35 \%$ were unlikely ( 0 through 4 ) to recommend the area.
- Residents in the age range of 18 to $34(62 \%)$ are more likely to recommend the area than any other age group. The closest age group is those 65 and older ( $56 \%$ ).
- Male respondents ( $53 \%$ ) are somewhat more likely than female respondents ( $47 \%$ ) to recommend moving to the area.
- Those reporting an annual household income of greater than $\$ 100,000$ are more likely ( $59 \%$ ) than those reporting under $\$ 30,000(42 \%)$, between $\$ 30,001$ and $\$ 60,000(43 \%)$, and $\$ 60,001$ to $\$ 100,000(56 \%)$.
- Education also plays a role. Nearly two-thirds of respondents ( $64 \%$ ) with a bachelor's degree are likely to recommend the area to someone compared to $39 \%$ of those with a high school diploma. Additional differences across education are reported in the table on the next page.
- $54 \%$ of residents not born in Sangamon County would recommend moving to the area compared $46 \%$ of people born here.
- Both questions discussed on this page are new and no longitudinal comparison exists.

$72 \%$ of parents rate the quality of their children's education as excellent or good If you bad to rate the quality of education your oldest (or only) child is receiving would you say that it is...?
Rating the quality of education as excellent or good
is more common among parents who are white $(73 \%)$, ages 18 to $34(84 \%)$, born outside the county ( $87 \%$ ), report a house hold income of greater than $\$ 100,000(98 \%)$, and those with less than a high school diploma ( $100 \%$ ). $71 \%$ of parents with children enrolled in a public school report this compared to
$88 \%$ of those with kids in private schools.

## $65 \%$ feel safe walking alone at night

 Do you feel safe or unsafe walking alone at night in your neighborbood?This sentiment is more common among respondents who are male ( $76 \%$ ), between the ages of 45 and $54(78 \%)$, and white ( $69 \%$ ). Income appears to be a large driver for respondents as those earning less than $\$ 30,000(44 \%)$ a year are nearly half as likely as those making $\$ 100,000$ $(83 \%)$ to report feeling safe walking alone at night in their neighborhood.

Respondents who are white ( $62 \%$ ), have less than a high school education ( $88 \%$ ), have a household income over $\$ 100,000(70 \%)$, are 65 and older ( $68 \%$ ), and not from Sangamon County ( $62 \%$ ) are more likely than others in their comparison groups to report having a great deal of trust in the local police.

## 70\% say Immigrants Help Sangamon County

This sentiment is more common amongst women ( $71 \%$ ), non-white respondents ( $78 \%$ ), those reporting an annual income between $\$ 60,000$ and $\$ 100,000(78 \%)$, respondents between the ages 18 and $34(86 \%)$, and those born outside of Sangamon County (77\%).

$57 \%$ have considered moving out of Sangamon County in the past year
In the past twelve monts,s, bave you considered moving out of or away from Sangamon County?
This sentiment is more common among respondents who are male ( $58 \%$ ), between the ages of 45 and $54(67 \%)$, those born in Sangamon County ( $63 \%$ ), and non-white ( $61 \%$ ). The biggest difference is between those with some college experience $(63 \%)$ compared to those with less than a high school diploma $(20 \%)$. The $57 \%$ of all respondents is over 20 percentage points higher than the $2017(36 \%)$ and $2015(35 \%)$ rates.
$79 \%$ think young people are better off moving out of Sangamon County
Do you think young people are better off staying in Sangamon County or are better off moving elsenybere?
Younger respondents, those ages 18 to $34(82 \%)$, had a higher percent of respondents reporting this position than most age groups. The highest are those ages 45 to $54(88 \%)$. White respondents $(80 \%)$ are more likely than non-white respondents ( $73 \%$ ) to share this sentiment. Slightly over onethird ( $36 \%$ ) of respondents with less than a high school degree report thinking younger people are better off moving away, the lowest of the education groups.

## $62 \%$ want the population of Sangamon County to increase

Over the next five years, would you like to see the population increase, stay where it is now, or decrease further?
$63 \%$ of white respondents report wanting the population of the county to increase compared to $57 \%$ of non-white respondents. Two-thirds ( $66 \%$ ) of those respondents born outside of Sangamon County report wanting the population to increase in comparison to $58 \%$ of those born in Sangamon

Country. The lowest level of support for a population increase when looking at age are those ages 18 to 34 and 35 to 44 at $56 \%$.

Respondents who say they have considered moving cite lower taxes ( $23 \%$ ) and economic development ( $20 \%$ ) as the top two changes that could get them to stay.

- $\mathbf{1 6 \%}$ of those ages 18 to 34 see being a person of color as a large barrier to career success in Sangamon County. This is the lowest of the five age groups.
- $26 \%$ of women think being a person of color is a large barrier compared to $21 \%$ of men.
- $\mathbf{4 0 \%}$ of those reporting an annual household income of under $\$ 30,000$ think being a person of color is a large barrier. The highest of the income groups.


## Being from Outside the Area as a Barrier to Career Success in the County

- $29 \%$ of all respondents rate being from outside the area as a large barrier to career success in Sangamon County.

- $\mathbf{5 6 \%}$ of respondents are aware of economic development efforts in the area.
- $\mathbf{3 0 \%}$ of respondents think Sangamon County has an excellent or good reputation for starting a business.
- $\mathbf{2 1 \%}$ of respondents report that Sangamon County has an excellent or good reputation for attracting new businesses.
- $19 \%$ of those surveyed think Sangamon County has an excellent or good reputation for retaining existing businesses.
- $21 \%$ of respondents think Sangamon County has an excellent or good reputation for attracting talented professionals.
- $18 \%$ of respondents think that Sangamon County has an excellent or good reputation of retaining talented professionals.

An important note about the responses to the economic development questions is that the former director of the Land of Lincoln Economic Development Corporation was publicly removed from his position a few days after the survey was sent to the public. Due to media coverage and nature of his removal, awareness of economic development efforts may have increased but negative assessments may have as well.

89\% of Sangamon County Residents see Developing Downtown Springfield as Important to the County. This is the highest percent since this survey began in 2013.

- 67\% of respondents rate downtown Springfield as either excellent or good for restaurants.
- $\mathbf{6 6 \%}$ of those surveyed rate downtown Springfield as either excellent or good for cultural activities.

- $27 \%$ of those surveyed rate downtown Springfield as either excellent or good for shopping.

- $27 \%$ of respondents rate the state of Sangamon County's economy as excellent or good.
- $\mathbf{5 6 \%}$ of those surveyed rate the state of Sangamon County's economy as fair.
- $17 \%$ of respondents rate the state of Sangamon County's economy as poor.
- $\mathbf{3 5 \%}$ of respondents born outside of Sangamon County rate the economy as excellent or good compared to $18 \%$ of those born in the county.
- $32 \%$ of non-white respondents rate the economy as excellent or good compared to $25 \%$ of white respondents.
- $41 \%$ of respondents with an annual household income of $\$ 100,000$ or greater report the local economy is excellent or good. Those reporting an annual household income of $\$ 100,000$ or greater are more likely than those reporting under $\$ 30,000(31 \% \%)$, between $\$ 30,001$ and $\$ 60,000$ ( $18 \%$ ) , and $\$ 60,001$ to $\$ 100,000(22 \%)$.
- $41 \%$ of those surveyed with a graduate degree rate the economy as excellent or good. This compares to $39 \%$ of those with less than a high school diploma, $20 \%$ of those with a high school diploma, $27 \%$ of those with some college but no degree, and $27 \%$ of those with a four-year degree.

## Could Not Afford Food in the Past 12 Months

- $18 \%$ of all respondents report that there was a time in the past 12 months where they could not afford food, the lowest reported rate since this survey began in 2013.
- $\mathbf{2 3} \%$ of female respondents report this compared to $12 \%$ of male.
- $\mathbf{2 5} \%$ of non-white respondents report this compared to $17 \%$ of white respondents.
- $\mathbf{6 0 \%}$ of those with less than a high school diploma report not being able to afford food. This is over twice as much as the next closest group, which is those with some college ( $25 \%$ )
- $\mathbf{4 5 \%}$ of those reporting a household income less than $\$ 30,000$ report not being able to afford food, nearly twice as much as the next closest group of those making between $\$ 30,000$ and \$59,999 (23\%).
- $\mathbf{2 9} \%$ of those surveyed between the ages of 35 to 44 report not being able to afford food. The highest of the five age groups.
- $22 \%$ of those born in Sangamon County report this compared to $14 \%$ of those born elsewhere.


## Could Not Afford Healthcare or Medicine in the Past 12 Months

- $28 \%$ of all respondents report that there was a time in the past 12 months when they could not afford healthcare. This is the highest rate since the survey began in 2013.
- $\mathbf{3 4 \%}$ of female respondents report this compared to $22 \%$ of male.
- $37 \%$ of non-white report not being able to afford healthcare compared to $26 \%$ of white respondents.
- $\mathbf{5 3} \%$ of those reporting a household income less than $\$ 30,000$ report not being able to afford healthcare, compared to just $8 \%$ of those reporting an income of greater than $\$ 100,000$.
- $\mathbf{3 6 \%}$ of those born in Sangamon County report this compared to $21 \%$ of those born elsewhere.

## Could Not Afford Shelter in the Past 12 Months

- $19 \%$ of those with some college report not being able to afford shelter. The highest of the education groups.
- $22 \%$ of those reporting a household income less than $\$ 30,000$ report not being able to afford shelter, compared to just $1 \%$ of those reporting an income of greater than $\$ 100,000$.


## Could Not Afford Utilities in the Past 12 Months

- Women $(28 \%)$, non-white respondents (30\%), those with less than a high school education ( $75 \%$ ), those making less than $\$ 30,000$ a year ( $59 \%$ ), ages 35 to 44 ( $32 \%$ ), and people born in Sangamon County ( $26 \%$ ) were more likely than others in their group to report having issues affording utilities.

White respondents ( $51 \%$ ) are more likely to report that most people can be trusted than non-white (34\%).

## Confidence in Local Elected Leaders?

$46 \%$ of Sangamon County residents reported being confident that local elected leaders can effectively address local problems. This evaluation was most common among female respondents ( $49 \%$ ), individuals ages 65 and older ( $54 \%$ ), white respondents ( $48 \%$ ), individuals making less than $\$ 30,000$ a year ( $53 \%$ ), those born outside of Sangamon County ( $51 \%$ ), and individuals with graduate degrees ( $63 \%$ ).


## Confidence in State Elected Leaders?

## $24 \%$ of Sangamon County residents reported being confident that State leaders can effectively address problems.

In general, women ( $30 \%$ ) are more confident in state elected officials than men ( $18 \%$ ). Individuals between the ages of 18 and 34 are the most confident ( $33 \%$ ) while those aged 35 to 44 and 45 to 54 are the least confident $(15 \%)$. Those without a high school diploma ( $47 \%$ ) have the highest level of confidence in elected state government officials of all the education groups. Those reporting an annual household income of less than $\$ 30,000$ are much more confident $(45 \%)$ than the other income brackets. Those born outside of Sangamon County ( $29 \%$ ) are more likely to express confidence in state government leaders than those born in Sangamon County (19\%).

## Confidence in Federal Elected Leaders?

$\mathbf{2 4 \%}$ of Sangamon County residents are confident that federal elected leaders can effectively address problems.
Women $(29 \%)$ are more likely than men ( $18 \%$ ) to report being confident in federal level leaders. Non-white respondents ( $34 \%$ ) are more likely than white respondents ( $21 \%$ ) to report being confident in federal elected officials. Those with less than a high school education ( $47 \%$ ) are more likely than other education groups to report being confident in federal elected officials. Those born outside of Sangamon County are more likely ( $28 \%$ ) than those born in Sangamon County (19\%).

## Health Status

When asked about their health in the past 30 days, $39 \%$ report that there was at least one day in which their physical health was not good, and $41 \%$ report at least one day in which their mental health was not good. $29 \%$ report having at least one bad physical health day and at least one bad mental health day in the past 30 days. These results vary greatly based on gender, race, income, education, age and whether someone is originally from the area.

When comparing 2019 rates to the 2017 edition of this survey we find that a higher percentage of Sangamon County residents in 2019 report that their physical health was not good on at least one day and a higher percentage report that their mental health was not good at least one day out of the month compared to 2017. Since 2013, reports of poor physical health decreased by about 14 percentage points, but reports of poor mental health have more than doubled.

## Healthcare

- $\mathbf{9 3} \%$ of all respondents report having healthcare. While slightly lower than 2017 and 2015, this is a higher rate than 2013.
- $\mathbf{8 9 \%}$ of all respondents report having a primary care physician, similar to rates in 2015 and 2017 and slightly higher than 2013.
- $\mathbf{9 4 \%}$ of white respondents report having healthcare compared to $87 \%$ of non-white respondents.
- $\mathbf{3 8 \%}$ of respondents with less than a high diploma report having healthcare. This is dramatically lower than other education groups.
- $\mathbf{8 4 \%}$ of respondents ages 18 to 34 report having healthcare, the lowest of the five age groups.

As visualized through the graph in the top right corner of this page, male and female respondents have large differences of opinion when it comes to the level seriousness of issues facing the county.

## Differing Views Across Race

The issue of greatest concern for white respondents is obesity ( $56 \%$ ) compared to the lack of access to mental healthcare $(49 \%)$ for non-white respondents. Nonwhite respondents were also nearly twice as likely $(30 \%)$ as white respondents $(17 \%)$ to report a lack of access to healthcare is an extremely or very serious issue.

## Income and Issue Seriousness

Those reporting an annual household income under $\$ 30,000$ a year highlight tobacco use ( $61 \%$ ) and a lack of affordable housing ( $56 \%$ ) as the two most serious issues. For those reporting an income between $\$ 30,000$ and $\$ 59,999$ obesity ( $52 \%$ ) and opioid abuse ( $50 \%$ ) were the two most cited issues. For those reporting $\$ 60,000$ to $\$ 99,999$ the two highest issues were obesity ( $60 \%$ ) and lack of access to mental healthcare ( $45 \%$ ). Those reporting an income of at least $\$ 100,000$ also selected obesity ( $55 \%$ ) and lack of access to mental healthcare ( $46 \%$ )

- Consistently, those not originally from Sangamon County rate cultural and recreation options in the county higher than those originally from Sangamon County.
- Of the two cultural options we've polled on since 2013 parks are tied for their highest rating and libraries are slightly below their 2017 high, which was a large increase from 2015.
- White respondents rate parks, educational opportunities, and outdoor concerts higher than nonwhite respondents.
- Men rate parks and community educational offerings higher than women while women rate libraries and outdoor recreation higher than men.
- Those respondents 65 and older are the most positive about cultural and recreation options in the county.
